### **Focus**

International Students

# **Level of Study**

Undergraduate - NCEA students

## **Purpose**

The Toroa International NCEA Undergraduate Fee Scholarship supports international students who are transitioning from New Zealand High School to study at Massey University, in alignment with Massey's diversification strategy and the goal of attracting students from diverse markets.

## **Value and Tenure**

The value of the scholarship is NZ\$5,000 towards the tuition fee, the tenure is one year.

# **Typical Number on Offer**

Multiple scholarships are available.

# Eligibility

Applicants must:

- be international students who are new to Massey University and intending to enrol, full-time, in their first 120 credits of an undergraduate degree in the year of the award.
- have studied at a New Zealand High School.
- have achieved University Entrance through NCEA to meet admission into their chosen programme of study at Massey University (or equivalent for non-NCEA New Zealand high school qualifications).

## **Selection Criteria**

The selection will be based on academic merit. Consideration of personal characteristics including country of residence will be given to ensure equitable awarding.

#### **Selection Committee**

The scholarship is awarded by the University Scholarships Selection Committee on the recommendation of a panel consisting of university staff from the Office of Global Engagement.

# **Conditions of the Scholarship**

To be eligible for this fee scholarship, students must have received an Admission Offer of Place into a full-time undergraduate degree at Massey University commencing in Semester One (February), 2025.

Recipients are required to pay the first-year full fees within 2 weeks of the scholarship award in order to secure the scholarship. Failure to make this payment by the due date will result in the scholarship offer being rescinded.

Recipients will have met University Entry through NCEA for admission into their chosen programme of study at Massey University. Equivalency will be considered for recipients who have studied at a New Zealand high school and completed non-NCEA qualifications (such as International Baccalaureate).

Applicants must be international students. This fee scholarship is not open to Australian or New Zealand citizens or permanent residents of Australia or New Zealand.

Applicants must be international fee payers only to be eligible for this scholarship.

This fee scholarship cannot be held with other scholarships, bursaries, or awards.

Applicants must be willing to participate and cooperate in marketing and communications activities (Scholarship Commitments) for their Faculty/Massey University. This may include testimonials and public relations opportunities, as well as being involved in and attending Open Events, Webinars or being a class representative.

Fee scholarships are not transferable or deferrable. They are valid only for use by scholarship winners in the academic year for which they have been awarded. Applicants who choose to defer entry will be considered for scholarships available in the year of entry. Accepting a scholarship before deferral does not guarantee a scholarship offer during the subsequent year of entry.

If awarded, the fee scholarship will be paid into the student's Massey Fee Account after the census date (last date of withdrawal without financial penalty)

Should the recipient withdraw from study in the first year, the scholarship will be withheld from any refunds.
