# **Project Description and Invitation**

# **Participant Identification and Recruitment**

Participants have been recruited through public lists, partnerships, and networks. We intend to maximise participation across different organisation types, sizes, and sectors, as more data allows us to provide valuable insights tailored to various organisations.

#### **Project Procedures**

Participants will complete a survey lasting approximately 15 minutes. There are no conflicts of interest, and no known risks associated with participation.

### **Data Management**

This survey is anonymous. Where participants are identifiable by their answers, responses will be anonymised to ensure anonymity. The data will be securely stored and used primarily to benefit organisations, with findings shared with relevant stakeholders. We do not plan to dispose of the data, as it may be used for ongoing comparative analysis to continue providing value to organisations. Anonymised findings will be made publicly available.
